VII. [Your Rights And The Law - A Guide Produced By The KCDHH](#)

Federal and state laws are in place to protect individuals with disabilities from discrimination. These laws were designed to give equal access and opportunities to all persons with disabilities, including individuals with hearing loss.

For an individual with a hearing loss, equal access typically means effective communication. Effective communication usually requires some form of accommodation and due to the diverse needs of deaf and hard of hearing individuals, the specific accommodation will depend on the individual.

Hear Now

Hear Now is an application-based program of the **Starkey Hearing Foundation** that provides new hearing aids to low-income Americans. For information about eligibility, contact the Starkey Hearing Foundation at: **(800)328-8602** and ask to speak with a Hear Now representative. Applications must be received by December 15th of each year to be considered.

Please understand that Audiologists/HHPs working with Hear Now donate their time and may have limited openings. SHARP and/or Hear Now are not able to make referrals or verify that an audiologist has current openings for Hear Now applicants.

Once the application has been completed by both the applicant and the Audiologist/HHP, please mail directly to Hear Now at: Hear Now Program, 6700 Washington Ave South, Eden Prairie, MN, 55344.

The applicant will need to enclose a **cashier's check** or **money order** for the balance of the Hear Now application fee (along with any other requested documentation).

Overview

Working closely with the medical community, the Gift of Hearing Foundation will provide financial support to help a select number of economically disadvantaged patients receive cochlear implants. We will use these selected cases to highlight the gaps in reimbursement for cochlear implants and advocate for change. We can provide financial assistance to those whose insurance coverage will not provide for the cost of CI Implants. We do not assist with hearing aids.

Eligibility Requirements and Application Process

Applications for assistance must be submitted through the cochlear implant center that has determined that the individual qualifies as a CI candidate. GOHF does not accept applications from individuals. A qualified CI candidate should have their CI audiologist or surgeon's office contact GOHF directly for an application.
